

Official Rules – SPASH Christmas Contest

From December 10th, 2025 to December 31st, 2025

Article 1 – Organizer

The contest is organized by **SPASH** (SIRET : 793 654 678 00024), a company specializing in sports video and AI technologies. The contest will run from **December 10th, 2025 at 00:00 AM** to **December 31st, 2025 at 11:59 PM**.

Article 2 – Eligibility

The contest is open to any individual:

- Playing in a club equipped with a SPASH system
- Registered on the SPASH application

Employees of SPASH, persons involved directly or indirectly in the contest organization, and their immediate family members are not eligible.

Participating in the contest implies full and unconditional acceptance of these rules. Any breach of the rules will invalidate the participation.

Article 3 – How to Participate

To participate, the participant must:

Step 1 – Submit a video in one of the 3 categories:

- **TOP FAIL**
- **TOP ACTION**
- **TOP FUN**

Step 2 – Submit their video using one of the 3 methods below:

1. Using the **“Contest”** button available on SPASH interfaces
2. Posting their video on social media with the hashtag **#SPASHcontest**
3. Sending their video via email to **infos@spash.com**

Participants must also authorize SPASH to use their video and image on its social media channels for communication purposes.

Any incomplete or incorrect participation will not be considered.

Article 4 – Winner Selection

At the end of the contest (December 31st, 2025 at 11:59 PM), **SPASH will select one winner per category:**

- **1 winner for TOP FAIL**
- **1 winner for TOP ACTION**
- **1 winner for TOP FUN**

The winners will be notified by SPASH starting **January 7th, 2026**.

Article 5 – Prizes

There will be **3 winners in total** (one per category).

Each winner will receive a **gift worth €100**, chosen from a selection provided by SPASH, including:

- Sportswear
- Wireless earbuds
- Football jersey
- Padel racket
- Other sports accessories

Prizes cannot be exchanged, refunded, transferred, or converted to cash.

Article 6 – Prize Delivery

Following verification of eligibility and compliance with the contest rules, winners will be contacted by SPASH.

Prizes will be shipped or delivered directly by SPASH.

Article 7 – Guarantees

The contest is organized in accordance with applicable legal and regulatory requirements.

SPASH guarantees the conformity of the prizes. In case of defects or malfunction, participants may contact SPASH within the limits of legal warranties.

SPASH cannot be held responsible in case of:

- Technical issues
- Internet outages
- Service interruptions
- Force majeure events

No compensation may be claimed in such cases.

Article 8 – Access to the Rules

The full contest rules are available online via a link shared on SPASH's official communication channels.

Article 9 – Liability & Force Majeure

SPASH reserves the right to modify, suspend, shorten, or cancel the contest if necessary and cannot be held liable for such decisions.

SPASH cannot be held responsible for:

- Fraud attempts
- Participation errors
- Technical issues
- Network failures
- Any event considered as force majeure

In such cases, prizes may not be awarded.

Article 10 – Availability

SPASH will make every effort to ensure optimal operation of the contest and the application. However, continuous, error-free 24/7 access cannot be guaranteed due to the nature of the Internet and IT systems.

No compensation will be granted for service interruptions.

Article 11 – Intellectual Property

All elements appearing on SPASH's platforms (text, images, graphics, logos, videos, software) are protected by intellectual property laws and are the exclusive property of SPASH or of third parties having authorized their use.

Participants agree not to reproduce, modify, or distribute any element without prior written authorization.

Article 12 – Data Protection

Personal data collected during the contest (name, surname, email, postal code, etc.) are necessary to manage the contest and contact winners.

Data will be processed in compliance with applicable data protection laws and will not be transferred to third parties except technical providers strictly necessary for contest administration.

Participants may request access, correction, or deletion of their data as permitted by law.

Article 13 – Governing Law

These rules are governed by **French law**.

In case of dispute and if no amicable resolution is reached, the matter will be submitted to the competent court of **Lyon, France**.
